FILLING A VACANCY BY CO-OPTION

In the event of the Parish Council having to co-opt a replacement councillor, and there having been several expressions of interest in filling the vacancy, the following process has been adopted to ensure a fair, but simple, process for selecting the best candidate. It is in line with procedures followed by other Parish Councils

Anyone co-opted under this process will remain in position until the date of the next elections.

- 1. Candidates are asked to submit in writing no more than 300 words to cover (i) brief details about themselves, (ii) why they want to be a Hambledon Parish councillor and (iii) why they are a good candidate for the position.
- 2. All submissions should be received by the Clerk from candidates within five days of a written request from the Clerk.
- 3. The Parish Council will then consider the submissions, and announce its decision, at the following meeting.
