Budget

Precept request was sent to Waverley on 5th January as requested. Amount requested 12,027.12, which represents an increase of 3.8% from last year.

Henry Smith Charity

Members will keep aware of any other opportunities within the village for grant recipients.

Nicholas Holder reported that WBC looking at ways to increase revenue without raising precept, including increasing and improving leisure centres.

4. PLANNING

- **-WA2017/2121: The Merry Harriers**. *Erection and extension to existing accommodation*. Currently pending decision. Recapped on the discussion had in relation to concerns on parking pressures and the note that was sent to Waverley. No response received as yet. **Action:** Nicholas Holder to contact Waverley and feedback to the Chairman.
- **-WA2017/1582/3: Potters Barn.** Noted that councillors had also raised concerns about health and safety (which is not a material consideration for planning) which were felt not to be represented strongly enough. A response to our letter was received from

Waverley and will be circulated to all councillors by e-mail following this meeting. Comments has also been received from West Surrey Golf Club who will address the H&S concerns should the development go ahead.

Action CW

-WA2017/2354: The Merry Harriers. *Ablution block and hard standing areas.* Councillors sought clarification on the amended title of the planning application "change of use". Also discussed a need for clarification on what exactly is being applied for. It was noted that it might be a "certified location", in which case, the field is not an official permitted campsite due to historical context. There followed a discussion around parking pressures as previously expressed.

In principle, councillors were agreed that the campsite is not a problem, although the parking pressures remain and indeed have the potential to increase and therefore should be addressed by the applicant. The views of the Nursery School, with whom there is an informal reciprocal parking arrangement, will be sought.

- a. **Action** CW: Letter to be drafted from HPC to WBC to represent these views.
- b. **Action:** Nick Holder to review all the planning applications and to check back with Waverley on the issues raised around reporting.

-WA2017/1855 Farm Cottage and WA2017/1936 Barn at Hambledon House

Noted that comments to WBC on both these earlier applications seem not to have been given due consideration. Discussed whether the Council should 'object' in the future rather than simply 'comment'.

Noted that previous permission at Farm Cottage was under a certificate of lawfulness. Have any considerations under that been brought forward within this most recent permission? **Action** CW to check this out.

Also noted the importance of correct record of pre-application advice.

- **-Loss of small dwellings** will be brought up by the Chairman and Clerk at the Housing Strategy Consultation meeting next week. Commented on a trend for extending smaller houses, which increases the pressure on the stock of smaller houses.
- **-Orchard Farm** Nothing futher to report
- Dunsfold Park Nothing further to report
