- a. WA/2018/1519 Erection of extension and alterations to existing garage to provide ancillary accommodation. The Sheiling, Petworth Road Permission was refused as the planning officer concluded that the proposal is not in accordance with the Development Plan and the benefits of the garage extension to provide a games room would not outweigh the adverse impacts in relation to the Green Belt, the AONB and the AGLV. As such, planning permission is recommended for refusal.
