2. Nomination papers must be delivered to the Returning Officer, Council Offices, The Burys, Godalming, Surrey, GU7 1HR from 9.30am on weekdays from Friday, 22 March but no later than 4 pm on Wednesday, 3 April 2019.
3. If any election is contested the poll will take place on Thursday, 2 May 2019 between 7:00am and 10:00pm.
4. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Council Offices, The Burys, Godalming, Surrey, GU7 1HR by 5 pm on Monday, 15th April 2019.
5. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Council Offices, The Burys, Godalming, Surrey, GU7 1HR by 5 pm on Wednesday, 24 April 2019.
6. Applications to vote by proxy at this election applied for on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Council Offices, The Burys, Godalming, Surrey, GU7 1HR by 5 pm on Thursday, 2 May 2019. The physical incapacity must have occurred after 5pm on Wednesday, 24 April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday, 24 April 2019.
