4. PLANNING

Planning applications

WA/2018/0355 Farm Buildings, Hambledon House – *Erection of 5 dwellings following demolition of existing commercial buildings.*

It was noted that the application has come from Hawksmoor Homes through an agent. It is missing information about the size of the area, in contrast to previous applications. It was agreed that more information is needed and therefore it was proposed to request a site visit with the architect and clarification from WBC. The Clerk will arrange this.

WA/2018/0370 1 Malthouse Cottages, Malthouse Lane – *Erection of a single storey extension*

Councillors noted the increase in size since the original building. They discussed the design and permitted development rules. It was agreed that there is no objection in principle to the extension.

Decisions on recent applications

WA/2018/0022: St Dominic's School – Erection of a performing arts building and a storage building – which has been withdrawn in its current form. It was noted that Bat Surveys need to be carried out between May and August after which they can resubmit.

A site visit is due to take place on 21st March at 11am. 4 representatives from HPC will meet Bob Beckley, the Interim Business Manager for the school.

WA2017/2354: The Merry Harriers – change of use and erection of ablution block – decision pending, target date was 13th Feb. The decision has been delayed whilst discussions are ongoing over parking and highways.

WA2017/2121: The Merry Harriers. *Erection and extension to existing accommodation.* – Full Permission granted

Subsequently, visibility is much improved.

It was noted that additional potholes have been carried out in Church Lane, although the recent adverse weather has caused more.

It was also noted that some of the bridleway and footpath signs need repairs. It was noted that the member of the public who attended the last meeting has raised concerns about the side of Hambledon Road from Woodlands Road to Beech Hill and beyond towards the Merry Harriers. It was noted that SCC do not have any funds available at the current time for a cycle path.
