 Cllr Payne reflected on the recent passing of Cllr Wieler and Cllr Sewell. He expressed great gratitude from Hambledon Parish Council for their contribution and service to the village and Council.

Cllr Deanus reported that the Planning Appeal by UK Oil and Gas (UKOG) has been allowed. This will allow the drilling / exploration of oil and gas at High Loxley, Dunsfold. Cllr Deanus agreed that it was a disappointment that there was no weight given to AONB or the views of Hascombe Hill. Local Plan Part 2 as expected has been thrown back.
- 22/91 Brief Verbal Report from the Borough Councillors on matters from Waverley Borough Council affecting this Parish. Cllr Deanus reported that the work to fix pot hole damage on Wormley Lane has not been completed. There will be future repairs to Petworth Road which Cllr Deanus will send through details of next week. HGV's on Markwick Lane is Cllr Deanus' No.1 priority. Funding will be allocated over the next two years. Crashmap UK has demonstrated that it is a bad area that needs monitoring.

- Data Retention Policy. Councillors agreed to 7 year retention plan. After which Minutes and items of historical interest will be given to the Surrey History Centre and all else will be disposed of. Cllr Payne and Cllr Grove will go through documents from the Parish filing cabinet
- Local Government Boundary Commision Review. Cllr Payne to follow up with Jeremy Hunt
- Proposal from Chiddingfold Parish Council to adjust the boundary with Hambledon Parish
 to include one of the Pockford Estate Cottages and Brookside in Chiddingfold Parish
 Chiddingfold Parish Clerk confirmed that this was a request from the Parish. Waverley has
 acknowledged Cllr Payne's request for further information. Consultation is underway
 amongst the residents concerned.
- Village response to the situation in Ukraine No updates
- Maintenance, highways, roadworks, hedges/ditches and rights of way
 - Cllr McKeith has reported that:
 Malthouse Lane will be closed for waterworks 15th- 20th June
 Wormley Lane burst water pipe remains unfixed
- Traffic and Speedwatch
 - No speedwatch has been held this month.
 - HGVs regular letters to regular offending companies are not making any progress
- Queen's Platinum Jubilee
 All Councillors agreed that the Jubilee celebrations were a huge success and Cllr Payne thanked Cllr Grove for her organisation of it

- Almshouses Cllr Sinnott noted that there was no update.
- **Nursery School** Cllr Milan reported that the nursery has received requests to take Ukraine children with local families from outside of the parish boundary . Cllr Milan questioned whether there could be a contribution from the Henry Smith fund to enable this. Further investigation is needed
- Village Hall Cllr Grove reported the internet was working well and was excellent value.
- **Hambledon Festival** —Cllr Sinnott reported planning was well underway. Cllr Payne confirmed that he will ensure the local media were aware of the fete. Cllr Underwood said that notices for the dog show would be put up on the common
- Village Shop Cllr Scott-Bishop reported the shop was doing fine and was busy with walkers.
- **St Peter's Church** Cllr Underwood reported that finances were a little down. St Peters is doing well and is supported by the village. It will be linked together with 3 other churches which will give more power to the church.

SALC Forum -

-The Clerk reported that Surrey's Police and Crime 5 point plan includes reduction of violence and protecting people from harm. One point relates to Safer Surrey Roads and that the Commissioner cited Chobham Parish and their HGV watch which has had success. Cllr Grove has confirmed this approach has not worked on Salt Lane.

-Reducing Carbon Emissions - the Clerk reported that at some point the Council will need to demonstrate a Sustainability Policy to reduce carbon emissions but no action is needed at this time.

-County Deals - Further investigation will be needed to understand the implication of these pilots
