- 23/86 Brief Verbal Report from the County Councillor on matters from Surrey County Council (SCC) affecting this Parish.
 - Cllr Kevin Deanus reported that maps showing the new HGV zones will be sent to the clerk by the end of the week. The new speed policy will be written by the end of the month and likely to be ready for a three month consultation period after summer.
- 23/87 Brief Verbal Report from the Borough Councillors on matters from Waverley Borough Council affecting this Parish.

Cllr Lauren Atkins was unable to attend the meeting and sent an update via email. She drew attention to the AONB consultation, HPC broadly support the changes. The Dunsfold Oil decision to allow oil and gas exploration is being challenged by Waverley. Munstead House has been bought by National Trust. She has been working to raise awareness of the Ask for Angela initiative, all pubs in her ward will display posters advertising the scheme. Lisa Townsend is keen to discuss police initiatives with local groups / neighbourhood watch coordinators. This will be added to the HPC July agenda for further discussion.

Cllr Jane Austin explained that there will be an Extraordinary Meeting held to discuss planning committees on 7th June. Elected ward representatives are being excluded from debating planning applications within their own ward. Councillors believe this change is being forced through and are totally against this change. An example was given that it could lead to Farnham representatives dealing with Hambledon business and removes all local knowledge from the decision. Councillors believe this is a threat to local democracy and will lead to poor decisions being made. Cllr Payne commented that it may be a political decision. On the face of it, the proposal does not make sense to remove local Ward councillors from the decision making. He stated that the point of local representation is just that. HPC will need to understand more about the proposal and will be following the decisions made carefully.
